The Zip Line Director is responsible for ensuring campers receive a safe, fun, and quality program. Directly responsible for the safe operation of zip line programs, facilities and equipment. Responsible for supervision of direct report staff.

Job Description

ROLE AND RESPONSIBILITIES

- Train, supervise and evaluate the zip line staff.
- Ensure BSA COPE procedures are followed by instructing and guiding staff and campers.
- Maintain and be responsible for the safety of all zip line related activities.
- Instruct campers to use the zip line safely.
- Ensure Campers are properly fitted with safety equipment.
- Maintain all zip line equipment and ensure that it is in good working condition. Submit any equipment recommendations for retirement and purchase as needed and required.
- Ensure that all records and equipment are properly maintained including any logs or reports as required.
- Maintain paperwork and ensure completeness and submit on time.
- Participate in camp-wide activities.
- Assist in the set up and take down of all camp facilities. Assist with the cleaning of all camp areas
 including restrooms and showers.
- Assist with meal service including setup, serving and clean-up.
- Submit a "closing report" at the end of the season which includes inventories, daily duties and suggestions for improvement the following year.
- Other duties as assigned.
